Employer hereby invites Contractors to submit their sealed tenders for the contract to be funded by NEF-CO:

• Development of design and estimate documentation, including examination, author's review, as well as exhibition of materials and execution of works on Capital repair of the network of street educational process in the city of Tetiyev, Kyiv region.

When preparing the tender offer, the Tenderer should take into account that the works under the contract will be tentatively started in July 2023 and should be completed in November 2023.

The equipment and related works that will be supplied under these lots are exempt from taxation in accordance with the procedure provided for by the Resolution of the Cabinet of Ministers of Ukraine No. 153 of 02/15/2002 "On the creation of a unified system of attraction, use and monitoring of international technical assistance". The contractor with whom the contract will be concluded will be obliged to compile and submit to NEFKO (in writing and electronically) information confirmation of the purchase of goods, works and services in a preferential regime with the funds of international technical assistance in accordance with the terms and forms of the Contract by the 15th of each month , for further submission to the bodies of the State Tax Service.

In order to be qualified for the award of the contract, Bidders must have the financial, personnel and technical capacity to perform the specified works and meet the following minimum requirements:

- a) The average annual income for the last 3 years (2019-2021) is at least EUR 500,000. Documentation for 2022 is provided for reference;
- b) Contractor experience in 3 contracts within the last 3 years with a total value of at least €500,000 that have been fully and successfully completed and that are similar to the proposed equipment and works.
- c) In the event of a SPCA tender, the lead partner must demonstrate at least 50% compliance with requirements (a) and (b) above;
- d) Non-fulfillment of the contract by the Tenderer (including SPKA members, if applicable) has not occurred during the last 3-x years (2020-2022);
- e) All pending legal proceedings against the tenderer (including members of the SPCA, if applicable) must not, in the aggregate, exceed 30% of the net asset value of the participant;

The customer reserves the right to cancel the tender in case of non-grant funding for the project.

The electronic version of the tender documentation in PDF and MS Word format will be posted on the official website of the City Council. In the event of a discrepancy between the versions of documents in PDF and MS Word formats, the PDF version will prevail. The Customer's address to which tenderers must send tenders is indicated below (paper version and electronic version).

All tenders must be submitted with a tender guarantee declaration.

Taking into account the short term of submission of tender offers, at the request of the Customer, Tenderers may provide additional clarifying documentation and information, which by its nature will not make any changes to the submitted tender offer.

The link for online participation will be given to those tenderers who submit their offers. If there are any force majeure circumstances at the time of the opening, the opening will be postponed until favorable circumstances occur, about which the participants will be additionally notified by sending an electronic message.
